 3. **JUVENILES UNDER 17** years of age **MUST** appear in person with a parent, guardian or proof of marriage.
- FAILURE TO APPEAR** as indicated above will result in an additional charge for "Violate Promise to Appear", and Warrants being issued.
- Deferred Disposition** is an option to keep the Violation from appearing on your driving record. If you would like to take advantage of this opportunity please inclose an additional \$50.00 (fifty dollars) and there will be a 30 (thirty) day probation period after full payment has been received. CDL holders are not eligible, and should contact the Court to speak to the Judge.
