1. IN PERSON: ON OR BEFORE the date shown (wait at least 2 business days after issue of citation), OR
2. BY MAIL: Complete the Mail Appearance Form below then return it, along with a Money Order or Personal Check or Cashier's Check, to the court indicated BEFORE the appearance date shown on the bottom of your citation. Please include the citation number on your payment.
3. JUVENILES UNDER 17 years of age MUST appear in person with a parent, guardian or proof of marriage.  
FAILURE TO APPEAR as indicated above will result in an additional charge for "Violate Promise to Appear", and Warrants being issued.  
Deferred Disposition is an option to keep the Violation from appearing on your driving record. if you would like to take advantage of this opportunity please enclose an additional \$50.00 (fifty dollars) and there will be a 30 (thirty) day probation period after full payment has been received. CDL holders are not eligible, and should contact the Court to speak to the Judge.

## DRIVING SAFETY COURSE (DEFENSIVE DRIVING) INFORMATION

### READ INSTRUCTIONS CAREFULLY - (Failure to do so may void your request.)

Under Sec. 143A-2, RMVL, the Court shall defer proceedings and allow you 90 days to present evidence that subsequent to the alleged offense, you have successfully completed a DRIVING SAFETY COURSE approved by the Texas Department of Public Safety, IF:

1. on or before your appearance date, you enter a plea of NOLO CONTENDERE OR GUILTY and present to the court a written request to take the course; (the proper form is provided above.)
2. you have a valid Texas Drivers license or permit;
3. you have not taken the course for dismissal of a traffic citation within 12 months prior to offense date and you submit a Sworn Affidavit to that effect; (the proper form is provided above).
4. you were not charged with the offense of speeding 25 MPH or more over the posted speed limit.
5. you sent \$135.00 for court cost (if within a school zone the court cost is \$160.00 for DDC). You must within 90 days supply the court with the DSC CERTIFICATE OF COMPLETION. The Court Copy must be sent to the Court. IF YOU FAIL TO COMPLY WITHIN 90 DAYS, an arrest warrant may be issued.
6. you furnished proof of liability insurance to the court.
7. If you take more than 30 days to pay a citation IN FULL, a \$25 time payment fee, mandated by the state, will be added to your total fee.
8. Disqualifications for DDC: Hit & Run, Involved in accident with damage to vehicle, fleeing, reckless driving, CDL violations considered "SERIOUS" in accordance with VCS Art. 6687b-2. Sections 26 A thru E.

DRIVING SAFETY COURSE REQUEST AND AFFIDAVIT ON THIS SIDE OF THE FORM. ALONG WITH PROOF OF INSURANCE AND COURT COSTS (\$135.00 / \$160.00 SCHOOL ZONE) MUST BE SUBMITTED TO THE COURT PRIOR TO TAKING ANY DSC CLASS/COURSE.
